It was strongly suggested that alternates be appointed to the Planning Commission and the Zoning Board of Appeals.

Payment of Township Accounts:

Budget Amendment: Motion by Pam Radabaugh with a second by Jim Webber to transfer \$10,000.00 from General Fund Reimbursements to General Fund Planning. This will result in a new total of \$32,620.00 in General Fund Planning **Roll call vote: Ayes; Harlan Reichle, Jim Webber, Anna Grobe, Bill Robinson and Pam Radabaugh. Nays; none.**

Budget Amendment: Motion by Pam Radabaugh with a second by Harlan Reichle to transfer \$10,000.00 from General Fund Reimbursements to General Fund Building and Grounds. This will result in a new total of \$21,506.00 in General Fund Building and Grounds. **Roll call vote: Ayes; Jim Webber, Anna Grobe, Pam Radabaugh, Bill Robinson and Harlan Reichle. Nays; none.**

Budget Amendment: Motion by Pam Radabaugh with a second by Anna Grobe to transfer \$50.00 General Fund Police Service to General Fund Board of Review. This will result in new totals of \$5,200.00 in General Fund Police Service and \$2,550.00 in General Fund Board of Review. **Roll call vote: Ayes; Harlan Reichle, Bill Robinson, Anna Grobe, Pam Radabaugh and Jim Webber. Nays; none.**

The following checks were paid in December and will be shown as an expense for December: General Fund check #569 in the amount of \$169.08, Park Fund check #1013 in the amount of \$19.66 and Fire Fund check # 1079 in the amount of \$72.98, all for electric and General Fund check # 568 to the Benzie County Sheriff's Office in the amount of \$150.00 for the Snowmobile Safety Program.

Motion by Pam Radabaugh with a second from Harlan Reichle to approve check #4109 thru check #4112 and check # 4114 through # 4147 to pay the Township accounts in the amount of \$13,314.35. Check # 4113 in the amount of \$455.00 is void. **Roll call vote: Ayes; Bill Robinson, Anna Grobe, Harlan Reichle, Pam Radabaugh and Jim Webber. Nays; none.**
