Nancy Simmons, Zoning Administrator- Land Use Permits are at 31 with about 25% of them for new construction.

Public input and general discussion: Wilfred Swiecki gave a report on the history of the Platte Lakes Improvement Association and the court proceedings of the court in relation to violations of the Hatchery and run offs. The Zoning Administrator was asked about the follow up from a meeting that was held on August 13. A letter was sent to the County and no response has been received. It was suggested that language be added to any future Land Use Permits.
